
PROFESSOR LANCE NECKAR TO SPEAK ABOUT NORTHROP MALL ON APRIL 20, 2004

The Cass Gilbert Society will present Lance Neckar on the topic Cass Gilbert and the Northrop Mall: Precedents, Methods, and Implications. In addition to Gilbert's plan for the University of Minnesota and the shaping of the Northrop Mall, Professor Neckar will briefly review Gilbert's work on the Minnesota State Capitol approaches, his scheme for Washington, D.C., and his relationship to the City Beautiful movement, and Gilbert's plan for the University of Texas. While Gilbert conceived of a design for the mall, Professor Neckar will describe how much of the work was carried out by Morell and Nichols between 1919 and 1951. Gilbert's architectural model for the campus also will be on display.

Lance Neckar is associate dean of the University of Minnesota College of Architecture and Landscape Architecture and a professor of landscape architecture. He has conducted research on the history of landscape architecture, primarily on the influence of Castle Howard on the eighteenth-century English landscape park; the work of landscape architect H.W.S. Cleveland, the designer of the Minneapolis park system; and the modernist work of landscape architect Christopher Tunnard.

Neckar is also a principal of the firm Landscape Research, which is working on the restoration of the grounds of the LeDuc House in Hastings and the landscape of Mayowood in Rochester.

Join us at the auditorium of Rapson Hall at the University of Minnesota College of Architecture and Landscape Architecture, 89 Church Street (off University Avenue and 17th Avenue S.E.), on Tuesday, April 20, at 7:00 P.M. Admission is free to Society members. There is a nominal charge for nonmembers. Refreshments will be served after the lecture. Parking is available at the Church Street Garage (\$2.50 per hour), directly across from Rapson Hall. Slightly further away are the Fourth Street Garage, Fourth Street S.E. at 17th Avenue S.E. (\$5.00 flat fee) and the surface parking lot at Fourth Street S.E. and 18th Avenue S.E. (\$3.25 flat fee).

REPORT FROM NEW YORK

In the February 2004 issue of With Respect to Architecture, the newsletter of the Minnesota Chapter of the Society of Architectural Historians, Patty Dean wrote about preservation battles at Ground Zero and the damaged state of Cass Gilbert's West Street Building, located just south of the World Trade Center site. When the south tower collapsed on September 11, 2001, flaming steel debris gouged out part of the exterior terra cotta and set the interior on fire. Exterior damage would have been much worse, if the building had not been covered with netting as part of an ongoing restoration campaign. Because of the superb engineering of the building and the extensive use of fireproof terra-cotta tile to protect the interior steel columns and floors, the building remained structurally sound, despite extensive interior fire damage.

On March 5, 2004, Glen Collins reported in the New York Times that the netting had been removed from the north façade of the West Street Building. The building has changed hands twice since September 11, and the current owner, Brack Capital Real Estate, is restoring the building for conversion to 410 apartments. Consequently, on a visit to New York in mid-March, I was anxious to see the building for myself. While the damage to the exterior terra cotta is still obvious, construction is moving forward rapidly. Its survival is testimony to the skill of Cass Gilbert and his engineering team.

As visitors to Lower Manhattan know, the destruction of the World Trade Center restored the visibility of the Woolworth Building to the skyline. Both it and Gilbert's New York County Lawyers' Association Building are within easy walking distance of the World Trade Center site.

After the property was acquired in 2000 by True Thao and Xoua Thao, they spent two-and-a-half years rehabilitating it to its historic grandeur.
